# **Background**

The WildNet data entry form has been created for Queensland government staff, approved external organisations and suitably qualified individuals to supply basic wildlife data for Queensland in a standard format to the Department of Science, Information Technology, and Innovation (DSITI) for incorporation within corporate applications.

The wildlife records supplied using the form are incorporated into the WildNet database and depending on access constraints agreed with the data providers can be made available via internal systems (WildNet and ecomaps) and internet sites as well as being provided to Queensland government agencies and to relevant clients under agreements.

The data provided using this form will assist with the planning and management of Queensland's resources including:

- · the conservation and management of specific wildlife;
- the management of areas such as national parks, state forests and marine parks;

- the maintenance of biodiversity through the provision of information to support planning and approval systems;
- research;
- · education; and
- community awareness.

WildNet and its data are accessed by staff within the following Queensland Government agencies:

- Department of Science, Information Technology and Innovation
- Department of Environment and Heritage Protection
- Queensland Parks and Wildlife Services within National Parks, Sport and Racing
- Department of Natural Resources and Mines, and
- Department of Agriculture and Fisheries especially Forestry.

WildNet's wildlife data contributes to a number of Queensland Government programs and products including Biodiversity Planning Assessment, Aquatic Conservation Assessment, State of the Environment reporting, Essential Habitat mapping, species habitat modelling, species assessment, management and recovery, reserve acquisition and management, Wetlands Program, The Species Recovery Information Gateway etc.

Currently the WildNet database delivers wildlife distribution data to external clients via a number of Queensland Government websites including:

- Species lists (formerly known as Wildlife Online) generate species lists for protected areas, forestry areas, LGAs and areas defined using coordinates
- Species profile search access species profiles and download records approved for publication (CSV, KML and GeoJson)
- Qld wildlife data API generate species lists and download records approved for publication (CSV, KML and GeoJson)
- Wetland Maps generate species lists and view species records, survey location approved for publication
- Wetland Summary access wildlife statistics and species lists for a range of area types including LGAs, national parks, basins etc.

Wildlife records approved for release to external parties are provided to the Atlas of Living Australia which is the Australian node of the Global Biodiversity Information Facility (GBIF).

## Instructions

The form includes drop lists and data validation to make data entry easier and minimise errors. If a field has not been completed correctly it will be highlighted in red and an error message is displayed.

Data may also be copied and pasted into the form (use the Paste Special – Values option), in which case any problematic records will be highlighted but no error message is displayed.

Drop list fields can be completed by either selecting the relevant code from the drop list, entering the code or by copying it from a completed field. The drop list fields are case insensitive (i.e. rf or RF can be entered for the vegetation code).

A number of fields are mandatory and must be entered for the record to be valid. The mandatory fields are denoted by an asterix (\*) below and are highlighted on the form until completed.

The form is locked to reduce users modifying it – this is because a data upload script has been written to process the completed forms for loading the data into WildNet. This can cause some issues relating to deleting rows in the spreadsheet. If you wish to remove a record just delete as many fields as you are able and write that the row is to be deleted in the Collection notes field.

### **Fields**

A description of each field and how it should be completed is detailed below.

**Number (max 15 characters):** Enter the number used to denote the record for reference purposes. You may wish to number the records sequentially e.g. 1, 2, 3 etc.

**Collector\* (max 200 characters):** Provide the full name of the person(s) responsible for the identification of the species.

**Start date\* (dd/mm/yyyy):** Provide the date of sighting or the first date of the field period. Only dates after 1900 can be provided using this form.

**End date (dd/mm/yyyy):** Last date of the field period if it is more than one day in duration (dd/mm/yyyy).

**Location\*** (max 240 characters): Provide a plain language description of the collection location. Ideally the description should include: a locality name, a distance and direction from a feature named on the gazetteer, and a broad region name (e.g. Peach Creek, 19km ENE of Mt Croll, Cape York Peninsula).

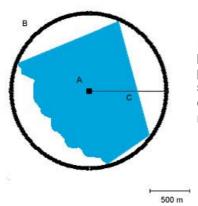
**Latitude\*/Longitude\* (max 15 characters):** Complete both of these fields or the UTM fields (i.e. Zone, Easting and Northing) **not both sets**. Provide the latitude in degrees, minutes and seconds or decimal degrees within the range of nine to 30 degrees South (e.g.23°26'13"S or - 23.43694444). Provide the longitude in degrees, minutes and seconds or decimal degrees within the range of 138 to 156 degrees East (e.g. 152°15'42"E or 152.2616667).

**Zone\*/Easting/Northing (max 2, 6 and 7 characters respectively):** Complete all of the UTM fields (i.e. Zone, Easting and Northing), or the Latitude and Longitude fields **not both sets**. Provide the number of the Universal Transverse Mercator (UTM) Zone from 54 to 56. Provide the UTM Easting between 170110.00 to 813930.00. Provide the UTM Northing between 6677420.00 to 9003800.00.

**Datum\*:** Select the code from the drop list indicating the horizontal datum used when recording the location co-ordinates. If the location was determined using a GPS check the unit's setup menu to determine the datum. If the location was determined using a map, check the map legend for the horizontal datum. The preferred datum to use is the Geocentric Datum of Australia 1994 (i.e. GDA94).

**Precision\* (max 5 characters):** Provide the accuracy of the location co-ordinates provided in metres. This represents the radius of a circle which would enclose the collection area. Please note that if you collect observations from a large area (throughout a property for example) then you need to give location co-ordinates representing the centre of that area, and a precision large enough to encompass the whole area sampled. Refer Figure 1.

In this example, if the shaded area represents a property that has been searched, then the central point (A) is where the latitude/longitude or UTMs should be recorded, the circle (B) completely encompasses the area searched, and the line (C) represents the precision that should be recorded - 1000 m in this case.

Altitude (max 5 characters): Provide the altitude of the site in metres.

**Vegetation code:** Select the code from the drop list indicating the vegetation predominant at the site.

**Landform code:** Select the code from the drop list indicating the small scale landform features predominate at the site.

**Slope (max 3 characters):** Provide the inclination of the land surface over a 20 metre interval expressed in degrees between 0<sub>°</sub> to 90<sub>°</sub>.

**Aspect (max 3 characters):** Provide the direction the slope of the land surface is facing in degrees between  $0^{\circ}$  to  $360^{\circ}$ .

**Scientific name\*/Common name\* (max 240 characters):** Provide either the full scientific name for the species e.g. *Acacia concurrens* or record the common name for the species. Where wildlife is only identified to the genus for plants just provide the genus name e.g. *Acacia* and for animals provide the genus name followed by sp. e.g. *Litoria* sp..

Separate records should be provided to detail different types of records for the same species at a site relating the other fields such as age, sex, breeding, identification, vetting stage and specimen details e.g. individuals that are collected and incorporated within curated collections at museums and herbaria (vetting stage = specimen) or retained (vetting stage = collected) versus individuals that are observed. For example, for a plant species at a location (e.g. Cycas megacarpa), you may provide three records for the species detailing that two specimens were prepared and sent to the herbarium, one specimen was collected for a personal field herbarium and it was estimated that 150 plants were observed at the site.

**Count (max 6 characters):** Provide the number of individuals encountered at a site. If a number is provided, a Count type must also be provided. If a species is not evident at a site but was actively searched for a 0 can be recorded and Z (True zero) must be selected for the Count type code.

**Count type:** Select the code from the drop list indicating the relevant count codes if a count was provided. The description of the count codes are:

- Accurate (A) the actual number of individuals present.
- Estimate (E) the number of individuals calculated to be present using an estimation technique.

- Rough count (C) an approximation of the number of individuals present when an accurate count is not possible.
- True zero (Z) stating that no individuals were present but were actively searched for.

**Age code:** Select the code from the drop list indicating the age class of the individual(s) if known.

**Sex code:** Select the code from the drop list indicating the sex of the individual(s) if known.

**Breeding code:** Select the code from the drop list indicating the reproductive condition of individual(s) if known.

**Identification method:** Select the code from the drop list indicating how the species was identified.

**Collector code (max 20 characters):** Provide the collector's identification code for the individual e.g. tag number.

**Specimen registration (max 20 characters):** Provide the registration number of the specimen stored at a museum/herbarium.

**Specimen location (max 60 characters):** Provide the name of the museum or herbarium where the specimen is stored.

**Collection notes (max 240 characters):** Provide any notes associated with the species record including samples collected, identification notes, behaviour observed etc. If the species identification was confirmed by another person or organisation details should be provided in this field e.g. ID confirmed by Queensland Herbarium.

**Vetting code\*:** Select the code from the drop list indicating the reliability of the taxon identification for this record. The descriptions of the vetting codes are:

- Specimen (S) a specimen-backed record, which has been identified by an expert and lodged in the collection of a formal institution. Examples would include Queensland Museum and Queensland Herbarium specimens.
- Collected (K) a specimen-backed record, which has been identified by an experienced observer but is not lodged in the collection of a formal institution. Examples would include material held in regional herbaria, local reference collections and material awaiting registration in formal institutions.
- Verified (V) an observational record which has been made or confirmed by a recognised expert in that taxonomic group. For example, all frog records submitted by Keith R.
   McDonald would be labelled as Verified as he is a nationally recognised expert on frogs.
- Confirmed (C) an observational record which has been made or confirmed by an
  experienced observer. This would typically include people with training in wildlife
  identification and experienced naturalists, such as university students, environmental
  consultants, and members of bird clubs and similar organisations.
- Unconfirmed (U) an observational record which has been made by a novice observer or by an experienced observer outside there area of expertise, or any observational record made beyond the expected range of a species. All records submitted without Vetting stage codes or by people of unknown or limited experience are assigned to this class.
