Notice of Environmental Impact Statement (EIS)

Proposed Saint Elmo Vanadium Project

An EIS for the proposed Saint Elmo Vanadium Project (the Project) has been prepared by Multicom Resources Limited (the proponent). The Project would be located in north west Queensland, approximately 25 kilometres east of Julia Creek within the McKinlay Local Government Area. The Project covers an area of approximately 8,882 hectares (ha) on mining lease application (MLA) 100162 and an approximately 180 ha area off-lease for the offsite Water Storage Facility and associated pipeline, located adjacent the Flinders River and partially within the Punchbowl Road Reserve, respectively.

The Project would involve the development of a shallow open cut mine and associated infrastructure, to facilitate the eventual target production of up to 20,000 tonnes per annum (tpa) of Vanadium Pentoxide. Run of mine operations, to support production, will be up to 15 million tpa. The Project would involve a processing facility, tailings storage facility, water management infrastructure, power plant, rail spur and access from the Flinders Highway. The life of mine would be at least 30 years, including construction, operation, decommissioning and rehabilitation.

Environmental Protection Act 1994 (Queensland)

Application was made by the proponent under the *Environmental Protection Act 1994* (EP Act) for a voluntary EIS for the Saint Elmo Vanadium Project. Under section 72 of the EP Act it was determined that assessment of the Saint Elmo Vanadium Project would be by EIS.

Environment Protection and Biodiversity Conservation Act 1999 (Commonwealth)

The Project was determined to be a controlled action (EPBC 2017/8007) under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The controlling provisions are sections 18 and 18A (Listed threatened species and communities).

The EIS process will assess potential impacts of the Project on the controlling provisions consistent with the bilateral agreement (section 45 of the EPBC Act) between the Commonwealth and Queensland governments for the purposes of the Commonwealth Government's assessment under part 8 of the EPBC Act.
