Draft terms of reference for an environmental impact statement

Proposed Saint Elmo Vanadium Project

Multicom Resources Pty Ltd (the proponent) proposes to develop a shallow open cut mine and associated infrastructure, to facilitate the eventual target production of 50,000 tonnes per year of Vanadium Pentoxide over at least a 30 year mine life. The project would require strip mining of 25 - 30 million tonnes of material per year within Mining Lease Application 100162, located approximately 25 kilometres east of Julia Creek in north west Queensland.

The Department of Environment and Science (the department) has approved an application for the proponent to voluntarily prepare an Environmental Impact Statement (EIS) for the project under the *Environmental Protection Act 1994* (EP Act).

The project is a controlled action (EPBC 2017/8007) under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The controlling provisions are sections 18 and 18A (Listed threatened species and communities). The EIS process will assess potential impacts of the project on the controlling provisions consistent with the bilateral agreement (section 45 of the EPBC Act) between the Commonwealth and Queensland governments for the purposes of the Commonwealth Government's assessment under part 8 of the EPBC Act.

The proponent submitted the draft terms of reference (TOR) for an EIS for the proposal to the department on 22 February 2018.
