Draft terms of reference for an environmental impact statement (EIS)Proposed Styx Coal Project

Styx Coal Pty Ltd and Fairway Coal Pty Ltd, both wholly owned subsidiaries of Mineralogy Pty Ltd, propose to develop a greenfield open-cut coal mine and associated project infrastructure which would involve the extraction of up to ten million tonnes per year of run-of-mine thermal and coking coal over a life of 20 to 25 years. The relevant mining tenures are mining lease application 80178. The EIS will consider a number of options for a new haul road and train load out facility to transport coal via existing North Coast Rail Line to ports. The proposed project would be located approximately 130 kilometres northwest of Rockhampton in the Styx Basin in Central Queensland.

The Department of Environment and Heritage Protection (EHP) approved an application for Fairway Coal Pty Ltd to voluntarily prepare an EIS for the project under the EP Act.

The project was determined to be a controlled action (EPBC 2016/7851) under the *Commonwealth Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The controlling provisions are sections 12 and 15A (World Heritage properties), 15B and 15C (National Heritage places), 18 and 18A (listed threatened species and communities), 20 and 20A (listed migratory species), 24B and 24C (Great Barrier Reef Marine Park) and 24D and 24E (A water resource, in relation to coal seam gas development and large coal mining development). The EIS process will assess potential impacts of the project on the controlling provisions consistent with the bilateral agreement (section 45 of the EPBC Act) between the Commonwealth and Queensland governments for the purposes of the Commonwealth Government's assessment under part 8 of the EPBC Act.

Fairway Coal Pty Ltd has prepared and submitted the draft terms of reference (TOR) for an EIS for the proposal to EHP.
