Draft terms of reference for an environmental impact statement (EIS) – Proposed Ensham Life of Mine Extension Project

Idemitsu Australia Resources Pty Ltd (Idemitsu), Bligh Coal Limited and Bowen Investment (Australia) Pty Ltd known as the Ensham Joint Venture proposes to develop the Ensham Life of Mine Extension Project. The proposed project would be located approximately 35km east of Emerald and 49km north-west of Blackwater in Central Queensland. The project site is approximately 2737 hectares covered by parts of mining leases (ML) 7459, ML 70326, ML 70365 and ML 70366 and a portion of Mineral Development Licence (MDL) 217.

The project would involve the extension of underground mining operations at the existing Ensham mine to approximately the year 2037. Thermal coal would be extracted from a single-seam using bord and pillar operations at the current planned production rate of 4.5 million tonnes per annum within existing mining lease areas and a new mining lease within a portion of MDL 217. Existing underground and surface infrastructure including road, rail and mine infrastructure equipment would be utilised. No additional surface infrastructure or surface disturbance is proposed within the new mining lease area.

On 24 April 2020, Ensham Joint Venture submitted a voluntary EIS application, which was approved by the Department of Environment and Science (the department) on 4 June 2020.

The project is a controlled action (EPBC/2020/8669) under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The controlling provisions are sections 18 and 18A (listed threatened species and communities) and sections 24D and 24E (a water resource, in relation to coal seam gas development and large coal mining development) of the EPBC Act. The EIS process will assess the potential impacts of the project on the controlling provisions consistent with the bilateral agreement (section 45 of the EPBC Act) between the Commonwealth and Queensland governments for the purposes of the Commonwealth Government's assessment under part 8 of the EPBC Act.

Ensham Joint Venture submitted the draft terms of reference (TOR) for an EIS for the proposal to the department on 13 July 2020.
