Queensland Interim State Disaster Management Plan 2024-25

October 2024 Amendment Schedule

1.0 - Introduction

The Queensland State Disaster Management Plan (SDMP) was initially released in 2018 and an interim update was released in April 2023. The update focused on Machinery of Government (MoG) changes that were published in the Government Gazette on 29 June 2021.

In July 2024 the Queensland Disaster Management Committee (QDMC) approved a three phased approach to the review and renewal of the SDMP, including the phase one addendum to the SDMP.

This Amendment schedule accompanies the Interim SDMP 2024-25 and completes phase two of the program.

3.0 - Phase Two

Phase two of the program focuses on ensuring the Interim SDMP 2024-25 is accurate and reflects:

- Administrative Arrangements Order (AAO) (No.2) 2023
- the Emergency Services Reform Amendment Act 2024
- the Disaster Management and Other Legislation Amendment Act 2024.

Changes of note include:

- the addition of key roles, groups and definitions
- an update to the Queensland Disaster Management Arrangements Triangle
- a re-write of Section 3: Risk
- partial redactions of Section 5: Resilience, Section 9: Recovery and Section 11: Assurance
- updating and aligning State Disaster Coordination Group (SDCG) member agency responsibilities to legislation.
