TO BE ELIGIBLE FOR THE 2024 QAIS BURSARY THE FOLLOWING CRITERIA **MUST BE MET**:

- the student is **not be eligible** to receive assistance through the <u>Living Away From Home Allowance</u>
 <u>Scheme</u> (LAFHAS); and
- the student must have a permanent home address in Queensland; and
- the nearest Queensland Government (state) school to the student's family home, with the appropriate year level is located in an Outer Regional Australia, Remote Australia or Very Remote Australia (as per the Department of Education State Schools zone);
- the student's travel is at least <u>three hours per day</u> from the student's permanent home address
 to reach the Academy they are attending, using school transport or <u>public transport service</u>; and
- the student must be enrolled in and have satisfactory conduct, progress and attendance at the Academy.

A new Bursary application must be completed each year.
