

## Resilient Homes Fund Hardship Certificate Application Form

This form is for homeowners registered with the Resilient Homes Fund Program seeking to waive co-contribution requirements for:

- Resilient Retrofit works above \$50,000
- Home Raising works above \$100,000

To be eligible for a Hardship Certificate, all owners of the home (as listed on the property title) must show evidence of meeting one or more of the eligibility criteria. The eligibility criteria is available on the Resilient Homes Fund website.

- Proof of income and/or hardship for all owners of the home.
